## Re: Freedom of Information Request FOI 4859

We are writing in response to your request submitted under the Freedom of Information Act, received in this office on 19th August 2021.

Your request was as follows:

Can you provide the number of COVID-19 cases that have occurred in both staff and patients at The Walton Centre, Sid Watkins Building between the dates of 20th July till the 18th August. We would like this data separated between staff and patients, providing a number for each.

I can confirm in accordance with Section 1 of the Freedom of Information Act 2000 (FOIA) that we do not hold the information you have requested relating to which building that patients Covid cases have occurred in and also Covid cases for staff members. Therefore we cannot provide this information.

Under the FOIA, we are not required to create this information in order to answer your request. I should explain that the FOIA is to do with transparency of information held by public authorities. It gives an individual the right to access recorded information held by public authorities. The FOIA does not require public authorities to generate information, or to answer questions, provide explanations or give opinions, unless this is recorded information that they already hold.

However I can confirm that The Walton Centre NHS Foundation Trust (WCFT) holds the information you have requested for overall patient oCvid confirmed cases within WCFT. I am unable to provide you with that information as I consider that the following exemptions apply to it:

## Section 21 - Information already reasonably accessible to you

This information is exempt from disclosure under Section 21 of the FOIA, as it is already reasonably accessible to you. The information you have requested is published on NHS England website. This exemption is not subject to the public interest test. This response therefore acts as a refusal notice under section 17 of the FOIA.
