Re: Freedom of Information Request FOI 5166

We are writing in response to your request submitted under the Freedom of Information Act, received in this office on 04th May 2022.

Your request was as follows:

The number of people who were infected with Covid-19 inside your hospitals since March 2020 - so the patients who tested positive for Covid-19 after testing negative when they were first admitted. Please may I have the figures broken down for the number of hospital-acquired infections for each individual hospital.

[The number of people who have been infected with Covid-19 at the Walton Centre NHS Foundation Trust since March 2020 is 110.](#)

The number of people who after being infected with Covid inside the hospital, then died of or with the virus, whilst in hospital, or after discharge since March 2020. Please may I also have these figures broken down for the number of deaths for each individual hospital.
