We are writing in response to your request submitted under the Freedom of Information Act, received in this office on 12th January 2023.

Your request was as follows:

1. How many external international hires have been made at The Walton Centre NHS Foundation Trust in 2021, and in 2022. Please can you share the total for each year separately, not a combined total.

Can you break this down by number of hires per role for each of 2021 and 2022. Please can you keep the response for each year separate.

(e.g 2021: 50 Nurse, 25 AHP, 3 Midwife, 10 Doctor, 30 Paramedic / 2022: 40 Nurse, 30 AHP, 10 Midwife).

The Walton Centre NHS Foundation Trust made the following international hires in 2021 and 2022:-

2021 - 48 nurses

2022 - 22 nurses

2. What is The Walton Centre NHS Foundation Trust total international recruitment spend for each period, excluding staff wages?

The WCFT's total international recruitment spend was:-
