Re: Freedom of Information Request FOI 5533

We are writing in response to your request submitted under the Freedom of Information Act, received in this office on 13th January 2023.

Your request was as follows:

Please can you tell me how many sexual abuse incidents and rapes (separately if you measure these separately, combined if you do not) have been recorded within your trust in the years: 2017/8, 2018/19, 2020/21, 2021/22, and 2022/23 so far.

If possible, could you also inform me of what the trust's response was to each of these incidents.

The Walton Centre NHS Foundation Trust has had 24 sexual abuse incidents since 2017/18. I can confirm that the Trust dealt with each incident in the appropriate manner.

(This has been provided as an overall figure as breaking the figures down into individual years would trigger a section 40 (2) third party data exemption under the FOIA 2000)
