**Re: Freedom of Information Request FOI 6166**

We are writing in response to your request submitted under the Freedom of Information Act, received in this office on 12th February 2024.

Your request was as follows:

I have enclosed a spreadsheet to use for the replies, for your ease of use. Alternatively, providing the information within the body of an email is fine.

1.  How many individuals have been prescribed cannabis-based medicinal products by your NHS trust in the following years - a) 2022, b) 2023?

a) 2022 - 66 patients

b) 2023 - 59 patients

2.  How many individuals under the age of 18 have been prescribed cannabis-based medicinal products by your NHS trust in the following years - a) 2022, b) 2023?

Zero.

3.  How many individuals have been prescribed cannabis flos (flower) by your NHS trust in the following years - a) 2019, b) 2020, c) 2021, d) 2022, e) 2023?

The Walton Centre NHS Foundation Trust have not initiated cannabis flos for any patients but have had one person who was admitted as an inpatient on 2 occasions and already had this prescribed from elsewhere, so it was continued during both their admissions (ie prescribed on the inpatient prescription so the patient could continue to take their own supplies, but no supplies made from here). We are unable to access details of when these admissions were.
