Re: Freedom of Information Request FOI 6180

We are writing in response to your request submitted under the Freedom of Information Act, received in this office on 19th February 2024.

Your request was as follows:

I am writing to you under the Freedom of Information Act 2000 to request the following information from Trust regarding.

The amount of:

1. How many RGN/RMN shifts have been filled using an "Off Framework" Agency between December 1st 2023, and February 1st 2024.

2. Which "Off Framework" Nursing agencies have been used by the Trust between December 1st 2023, and February 1st 2024.

3. A break down of shifts filled by each "Off Framework" agency between December 1st 2023, and February 1st 2024. E.g. 3 RMN Shifts and 5 RGN shifts were filled by X agency.

4. The total cost for each individual "Off Framework" nursing agency between December 1st 2023, and February 1st 2024.

I can confirm the Walton Centre NHS Foundation Trust did not use any 'Off-Framework' agencies between December 1st 2023 and February 1st 2024.
