We are writing in response to your request submitted under the Freedom of Information Act, received in this office on 02nd January 2024.

Your request was as follows:

All expenditure made by your organisation, in every facet of its operations and purview, on translation, interpretation, and language services.

Please provide the aggregated total spent by your organisation and then, if possible, please provide this broken down by particular function for which the service was carried out.

I can confirm that the Walton Centre NHS Foundation Trust had the following expenditure for translation, interpretation, and language services for the years requested:-

20/21 - £39,121.19 21/22 - £67,701.95 22/23 - £89,394.70

We are unable to provide a breakdown for each function due to the number of invoices and timesheets that would require a staff member to audit and correlate to breakdown this information, which in doing so would take us over the appropriate limit of 18 hours.
