We are writing in response to your request submitted under the Freedom of Information Act, received in this office on 12th January 2024.

Your request was as follows:

I am reaching out to formally submit a Freedom of Information request to obtain detailed information regarding the fleet of CT and MRI machines within your trust.

I kindly request that you provide the number of CT and MRI machines, categorised based on ownership (owned or rented) for the years 2019, 2020, 2021, 2022, and 2023, along with details regarding the age of the owned machinery for the year 2023 only.
