Re: Freedom of Information Request FOI 6122

We are writing in response to your request submitted under the Freedom of Information Act, received in this office on 18th January 2024.

Your request was as follows:

This is a request for information under the Freedom of Information Act 2000. My request relates to finding out if all NHS staff are supposed to have mandatory training in how autistic and people with learning difficulties present in hospital.

I would like to request the following information:

• What percentage of NHS staff in your trust have received training on how with patients with autism and learning difficulties present in hospital?

All staff are required to complete e-learning on Learning Disability Awareness and Oliver McGowan training. As of 31/12/23, LDA in-year compliance was 90%. Oliver McGowan rolled out Trust wide (to all staff) in September 23; compliance 64% as of 31/12/23. Neurodiversity Awareness sessions are also delivered to a mixture of staff and managers but compliance not reported (non-mandatory training). X4 staff members additionally completed a Neurodiversity Workplace Champions qualification.

•□How long is the waiting list for training NHS staff in your trust on how patients with autism and learning difficulties present in hospital? Please give in days, weeks or months

N/A mandatory training accessed via e-learning

•□How often is training for NHS staff in your trust provided in how autistic and people with learning difficulties present in hospital?

LDA and Oliver McGowan e-learning training completed every 36 months. Additional training provided ad-hoc.

• □ Do you have any plans in place to train all NHS staff in your trust within the next 12 months? (in relation to how autistic and people with learning difficulties present in hospital)

As above, LDA and Oliver McGowan is mandatory for all staff members. Neurodiversity Awareness training day aimed specifically at Consultants planned. Further additional training may be provided (funding dependent).
