Re: Freedom of Information Request FOI 6142

We are writing in response to your request submitted under the Freedom of Information Act, received in this office on 26th January 2024.

Your request was as follows:

I am writing this email to inquire about access to information on generalized Myasthenia Gravis. I would like to submit an FOI request to the NHS Foundation Trust for the following information below:

Time Frame: October 2022 - September 2023

1. How many total generalized Myasthenia Gravis patients were treated in the hospitals (Inpatient & Outpatient)

I can confirm between October 2022 and September 2023, the Walton Centre NHS Foundation Trust treated 443 patients with generalised Myasthenia Gravis.

2. How much volume in mg was used for the following therapies:

Immunosuppressants

- a. Azathioprine
- b. Methotrexate
- c. Mycophenolate mofetil

Anti-CD20 - Rituximab

- a. MabThera
- b. Rituximab Biosimilars

Anti-FcRn

a. Vyvgart (Efgartigimod)

Complement Inhibitors

- a. Soliris (Eculizumab)
- b. Ultomiris (Ravulizumab)

Immunosuppressants - these are prescribed by GPs under a shared care agreement and WCFT do not hold this information.









Anti-CD20 - Rituximab - WCFT use Rituximab for a variety of different Neurological conditions at a standard dosing of Rituximab 1g STAT regimes repeated not sooner than 6 months based on clinical decision. Pharmacy are not informed if this will be for MG, so we are unable to provide information on the total mg used.

Anti-FcRn - a. Vyvgart (Efgartigimod) - approx. 124400mg in total on weight based cycles during the period requested.

Complement Inhibitors - I can confirm these are not used for Myasthenia at WCFT.

Please see our response above in blue.
