**Re: Freedom of Information Request FOI 6143**

We are writing in response to your request submitted under the Freedom of Information Act, received in this office on 26th January 2024.

Your request was as follows:

1.  How many iron extravasations have been reported within your organisation, if possible, could I have a 5- or 10-year breakdown?

I can confirm that the Walton Centre NHS Foundation Trust have not had any reports of iron extravasations over the last 10 years.

2.  Do you know how often IV iron is given, prescribed and used within the organisation?

IV Iron is prescribed in the WCFT approximately 6-8 times per year.

3.  Are patients given any information leaflets/documents prior to infusion? May I have a copy?

The WCFT do not have a specific information leaflet that is provided to patients, however patients may be given the manufacturers leaflet.

4.  Do you have an iron infusion policy - May I kindly have a copy?

I can confirm that the WCFT do not have an iron infusion policy.
